Re: Homelessness and Housing Affordability in Clinton

SUMMARY:

Homelessness and lack of affordable housing are immediate concerns in Clinton that require a rapid response. In 2016, a study by the United Way of Clinton County found that 43% of Clinton households struggle to cover their basic costs of living, ultimately leaving them at risk of homelessness.¹ There are around 300 homeless individuals in Clinton.

Increasing rates of poverty as well as a lack of quality housing units, jobs, and accessible resources exacerbate homelessness in rural communities. If these challenges are not addressed, individuals and families will continue to experience generational poverty and homelessness in Clinton.

BACKGROUND:

One of the challenges with homelessness in Clinton–as with many small towns and rural locales– is that it is hidden from public view. Often, people experience periods of transitional homelessness, which consist of "couch surfing," accessing space in emergency homeless shelters, and living in motels/hotels, cars, or abandoned houses.²

In addition, Clinton suffers from an aging housing stock. Out of the 12,202 housing units in the city, about 88% is more than 40 years old, while only 694 units have been built since 2000.³ The upkeep needed for this type of aging housing stock can be difficult to manage if landlords and owners are not proactive in their maintenance.

Accessibility to resources is also a barrier for citizns of Clinton who find themselves in need of housing assistance. The Clinton Housing Authority has no online presence outside of a phone

number and an address, which makes it very difficult to access housing resources and information.

Finally, there has been a decline in locally owned properties. Cheryl Wilson, a member of the Clinton Housing Authority, reported that many local landlords who used to own more affordable housing have recently had their properties bought by out-of-state contractors. As a result, this has driven up the price of rent, providing yet another barrier to affordable housing.

CURRENT EFFORTS:

Current efforts in place to help those who are homeless in Clinton include:

• The Victory Center

A 9-month faith based, Christ-centered teaching and financial planning course that supports its residents' transition to self-sufficiency.⁴ Entry into the Victory Center is voluntary, and their programs cost \$50 a month for the men's and women's shelter. The transitional housing has a monthly cost of \$430.⁵

• National Housing Trust Fund

There is not currently a shelter in Clinton, but the city just received a \$4.4 million grant through the National Housing Trust Fund that will be used toward resources for homeless citizens.⁶ Clinton plans to use this money to build a development that will house 24 chronically homeless individuals, 10 emergency shelter beds, a hot kitchen, a public mail center, a public shower center, community college programming, on-site mental health facilities, and provide a nurse practitioner for residents.⁷

Clinton Community School District

Currently, the school district receives \$100,000 a year for homeless children. This money is used to help them stay in school and receive resources beyond what their parents can provide, including clothing, school fees, school supplies, immunizations, food, medical or dental services, counseling services, and other resources that children need to attend school.^{8 9} This program helps to keep children in school and prevent them from falling behind due to homelessness.

POLICY RECOMMENDATIONS:

1. **Develop a website for the Clinton Housing Authority**. An online presence ensures that citizens can quickly obtain information about housing programs offered in Clinton, check

their eligibility for these programs, apply for housing, and immediately access resources from area nonprofits if they're in urgent need of assistance. By creating an easy to navigate website, the Clinton Housing Authority can further complete its mission of providing safe, affordable, and accessible housing for its citizens while amplifying and connecting a variety of nonprofit resources. - 2. Create an infographic outlining the Good Samaritan Law. Drug use and homelessness are often connected, and it is important for all people to know their rights and know they are protected if they call 911 to get help for someone who may be experiencing a drug overdose. Removing these barriers to information will allow for the protection of and safety for all members of the community. (Full draft infographic available in Appendix).
- 3. Host a meeting for all of the landlords in Clinton. This meeting would outline the benefits of participating in Section 8 housing and create an environment that is conducive to learning and effective communication. Landlords will better understand the need for affordable housing in Clinton, and how participating in Section 8 could directly benefit them. (Draft meeting agenda available in Appendix).

CONCLUSION:


These are immediate issues that must be addressed promptly and carefully. In order to create a coordinated response to the rising issues surrounding housing in Clinton, members of the City Council, Clinton Housing Authority, YWCA, Clinton Community School District, and any other relevant stakeholders should meet to develop a strategic plan for improving housing conditions. This plan may include increasing funding for housing-related initiatives beginning in fiscal year 2024, reviewing the efficacy of current efforts, and working to abate existing stigma surrounding homelessness in Clinton. With a proper plan, Clinton will have the opportunity to track the progression of housing measures taken and will be able to adjust accordingly to changes within the community.
